Board of Aldermen Session Meeting Minutes February 4, 2020

- 1. MAYOR MORTON called the meeting to order at 7:00 pm. All present recited the Pledge of Allegiance. A moment of silence was held for George Cromer. ALDERMAN BABINEAUX, DUDTE, CHARRETTE, LIECHTI, COHEN and THERING were present. A quorum was verified.
- 2. The January 21, 2019, meeting minutes were reviewed by the Board of Aldermen.
- 3. The Board of Aldermen reviewed the bill list.
- 4. ALDERMAN CHARRETTE stated there were a lot of potholes around the City. ALDERMAN DUDTE inquired about dirt runoff from the sidewalk installation in front of the 4-plex. ALDERMAN LIECHTI stated that there was a street sign leaning at the intersection of McPherson and Washington Street. He also mentioned a drainage ditch issue on Madison Avenue. The Public Works Dept. said they would look into the issues. MAYOR MORTON thanked the Public Works Department for their snow removal during our relentless weather. He also mentioned the need for the Board to address snow route issues. Building Inspector Bart Amsbaugh thanked Paul Bertschy for his help while he recovered from surgery. He also said there were a lot of utility maps at the Road Barn that need to be digitalized. CITY COLLECTOR Christina Limback stated that with the Board requested upcoming RFP's for Auditing Services, she stated that she felt it would be easier on City staff if the City retained the auditors used for the last 10 years. She also stated that the stop sign on her road is not red but pink (from fading). STEVE ASHBRIDGE of the Fire Dept. stated that the ISO rating numbers will be delivered at the next meeting by CHIEF JOHNSON. CHIEF BRIAN KNISKERN stated that he had a bill from Blue Valley Public Safety for sire repair that JoCo EMA will be taking care of since they have taken over the City's dispatching. The Planning and Zoning Commission did not meet this month as there was no business. The Parks and Recreation Commission will meet on February 11, 2020 at 6:00p.m. to finalize bylaws.
- 5. Mr. Steve Ashbridge of 807 Hardy Street thanked the City for their support and ALDERMAN CHARRETTE for his donation to his wife's memorial. Mr. Paul Bertschy, 10117 Knob Noster Road, stated that when the Public Works Dept. gets bids for equipment that they are sure that the City-owned attachments will work with it.
