## Board of Aldermen Session Meeting Minutes—November 21, 2023

- 3. ALDERMAN THERING to approve the consent agenda, as amended, consisting of a motion:
  - a. Approving minutes of the November 7, 2023, Board of Aldermen meeting.
  - b. Approving the 2024 GFI Digital Copier Lease.

ALDERMAN BYERLY seconded the motion. Motion carried 4 ayes to 0 nays.

- 4. The Board of Aldermen reviewed the bill list.
- 5. ALDERMAN BYERLY stated that there would be a Town Hall meeting and the Trails Regional Library on November 30, 2023. ALDERMAN PALMER reminded all that this Saturday is Shop Small Weekend in Knob Noster. ALDERMAN THERING relayed that the Public Hearing for the B21 Raider Environmental Impact is November 30, 2023, at the KN High School from 5:30-7:30pm. He wished all a Happy Thanksgiving. ALDERMAN CHARRETTE relayed that Knob Noster donation participants had been able to send two airman home, from our sister squadron, for the holidays. Great job all! ALDERMAN STAUFFER-BAUM stated that T-Mobile has Hometown Grants available for communities our size. They are looking for shovel-ready projects. The P&Z Commission began work on this project in August, has held all appropriate Public Hearings and has submitted, via Bill, to the Board to approve the Special Use Permit requirement for RV Parks in a C-2. The Board of Aldermen state that there are not any specifications or requirements for the Special Use Permit and those requirements would need to be spelled out.
- 10. Motion to set aside Item 10, Knob Noster Police Goal Setting Session, due to Chief Van Vickle being out on an emergency call, was made by ALDERMAN CHARRETTE with a second by ALDERMAN THERING. Motion carried 5 ayes to 0 nays.
- 11. Motion was made by ALDERMAN BYERLY to enter into Closed Session at 6:53pm pursuant to Section 610.021 RSMo, Paragraph 3, Personnel and Paragraph 2, Real Estate with a second by ALDERMAN STAUFFER-BAUM. Motion carried 5 ayes to 0 nays.
