ORDINANCE NO.

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH AUTO BRITE, INC. FOR USE OF THE RIGHT OF WAY FOR ELECTRIC VEHICLE CHARGING STATIONS.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:

SECTION ONE: The Mayor is hereby authorized to execute an agreement with Auto Brite, Inc. for the use of the City right-of-way for electric vehicle charging stations. The form of the agreement shall be substantially similar to Exhibit A, attached.

SECTION TWO: This Ordinance shall be in full force and effect upon final passage and approval by the Knob Noster Board of Aldermen.
