AN ORDINANCE AMENDING THE CHARGE FOR WATER-SERVICE CONNECTIONS AND REPEALING ORDINANCE 841

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:

WHEREAS, the average cost incurred by the City for installing a new water service connection tap and meter is \$1,000.00 for a 5/8" X 3/4", a 1" is \$1,200.00 and a 1 1/2" and larger is \$5,000.00.

WHEREAS, in order to maintain fiscal responsibility, not only to the revenue bond holders of the City's combined water and sewerage system, but to its existing water and sewer system users who would, otherwise, effectively subsidize new applicants for service, it is obligatory that the City adjust its charge for new service connections to a sum that will enable the City to reimburse itself for its actual expenditures.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI AS FOLLOWS:

Section 1. The connection charge hereafter imposed upon applicants for water service shall be:

<u>Meter Size</u>	<u>Charge</u>
5/8" X 3/4"	\$1,000.00
1"	\$1,200.00
1 1/2" and larger	\$5,000.00

Section 2. This Ordinance shall be in full force and effect from and after its passage and approval. Read two times, by title only (after having been made available for public inspection prior to the time the bill came under consideration by the Board of Aldermen), passed and approved on this 5th day of September, 2023.
