NOW THEREFORE BE IT RESOLVED, by the Board of Aldermen of the City of Knob Noster, Missouri as follows:

**SECTION 1**. The following vote was noted and recorded concerning the April 2, 2024, General Election held in the City of Knob Noster, Missouri on April 2, 2024:

<b>SECTION 2.</b> As certified by the Johnson County Clerk, Perry Byerly received 59 votes and Derrick Liggett received 50 votes; Perry Byerly is elected as Ward I Alderman for two years, Jesse Stauffer-Baum received 107 votes to be elected as Ward II Alderman for two years, and Josh Link received 61 votes and Christopher S. Dennis received 51 votes; Josh Link is elected as Ward III Alderman for two years but he has relocated and created a vacancy in Ward III.

That is further found, declared, and determined that notice of said election was duly given and published in the manner provided by law, and that said election was held and conducted in all respects in conformity with the Constitution and Laws of the State of Missouri, covering election in cities of the fourth class.
