AN ORDINANCE TO AMEND CHAPTER 215.050, ARTICLE IV, CERTAIN DEBRIS—NUISANCE BY ADDING SECTION 215.055 PERTAINING TO TREES OVERHANGING THE STREET RIGHT-OF-WAY

- **NOW, THEREFORE**, be it ordained by the Board of Aldermen of the City of Knob Noster, as follows;
- **SECTION 1**. That Chapter 215.055 shall be added in the Knob Noster Municipal Code and does read as follows:
 - **"215.055 Trees overhanging street right-of-way.** Trees overhanging the street are to be trimmed to a minimum height of fourteen (14) feet above the street surface. Dead trees and fallen limbs are to be removed from the premises."
- **SECTION 2.** The provisions of this Ordinance shall be incorporated into the Knob Noster Code of Ordinances.
- **SECTION 3.** This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approved by the Mayor.
