ORDINANCE NO.

**AN ORDINANCE TO AMEND CHAPTER 215.050, ARTICLE IV, CERTAIN
DEBRIS—NUISANCE BY ADDING SECTION 215.055 PERTAINING TO
TREES OVERHANGING THE STREET RIGHT-OF-WAY**

NOW, THEREFORE, be it ordained by the Board of Aldermen of the City of Knob Noster, as follows;

SECTION 1. That Chapter 215.055 shall be added in the Knob Noster Municipal Code and does read as follows:

“215.055 Trees overhanging street right-of-way. Trees overhanging the street are to be trimmed to a minimum height of fourteen (14) feet above the street surface. Dead trees and fallen limbs are to be removed from the premises.”

SECTION 2. The provisions of this Ordinance shall be incorporated into the Knob Noster Code of Ordinances.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approved by the Mayor.
