RESOLUTION 419

A RESOLUTION OF THE BOARD OF ALDERMEN ESTABLISHING THE ANNUAL RATE OF PROPERTY TAX FOR THE CITY OF KNOB NOSTER FOR THE NEXT TWELVE MONTHS

NOW, THEREFORE, BE IT RESOLVED, by the Board of Aldermen of the City of Knob Noster, Missouri, as follows:

That there be and is hereby levied a tax for the City of Knob Noster, Missouri, beginning on January 1, 2024, and continuing through December 31, 2024. The tax shall be as follows:

- a. <u>GENERAL FUND</u>: The sum of sixty-seven and fifteen hundredths cents (\$.6715) per one hundred dollars (\$100.00) of the valuation assessed of all property listed for taxation in said City.
- b. <u>FIRE REVENUE</u>: The sum of thirty cents (\$.3000) per one hundred dollars (\$100.00) of the valuation assessed of all property listed for taxation in said City.
- c. <u>GENERAL OBLIGATION BOND</u>: The sum of twenty-six and ninety-six hundredths cents (\$0.2696) per one hundred dollars (\$100.00) of the valuation assessed of all property listed for taxation in said City.

This Resolution shall be in full force and effect from and after its passage by the Board of Aldermen of Knob Noster, Missouri.
