Board of Aldermen Session Meeting Minutes—May 20, 2025

- 1. MAYOR CARTER called the meeting to order at 6:00 pm. All present included: ALDERMEN PALMER, BYERLY, THERING, CHARRETTE, SMITH and STAUFFER-BAUM appeared in person. A quorum was verified.
- 2. ALDERMAN THERING made motion to approve the Agenda with a second by ALDERMAN THERING. Motion carried 6 ayes to 0 nays.
- 3. ALDERMAN THERING to approve the consent agenda consisting of a motion:
 - a. Approving minutes of the May 6, 2025, Board of Aldermen meeting;

ALDERMAN SMITH commended Public Works for their assistance blocking roads for the Wine Stroll. He relayed that there is a water runoff issue at the church on Washington Street because their sump pumps are continually running. He said that the Knob Noster Panther Baseball team will be playing in districts on Friday evening at 7:00pm in Odessa, Missouri. ALDERMAN BYERLY also congratulated the 2025 graduates. He said the last day of school was May 21, 2025, and to keep an eye out on the road for youngsters. He said that he had attended our Sister Squadron's committee meeting where discussions included a BBQ in June and in August, a family picnic. He feels that it would behoove the City to create a military committee to collaborate closely with the squadron.

- 7. There was no virtual or in-person public participation.
- 8. Presentation was made by Joe McLiney of Mcliney and Company regarding fiscal development, bonds, and financing for the City of Knob Noster.
