

**CITY OF KNOB NOSTER**  
**Board of Aldermen Session**  
**Meeting Minutes—August 19, 2025**

1. The Pledge of Allegiance was recited by all in attendance. Invocation.
2. MAYOR CARTER called the meeting to order at 6:00 pm. All present included: ALDERMEN THERING, CHARRETTE, BYERLY and SMITH appeared in person. A quorum was verified.
3. ALDERMAN BYERLY made motion to approve the Agenda with a second by ALDERMAN SMITH. Motion carried 4 ayes to 0 nays.
4. ALDERMAN BYERLY to approve the consent agenda consisting of a motion:
  - a. Approving minutes of the August 5, 2025, Board of Aldermen meeting.ALDERMAN THERING seconded the motion. Motion carried 4 ayes to 0 nays.
5. The Board of Aldermen reviewed the bill list.
6. ALDERMAN CHARRETTE asked about pothole road repair. ALDERMAN SMITH thanked Public Works for the road and curb cleanup at Hillcrest and Summit.
7. The City Administrator presented his report.
8. There was no virtual nor in person public participation.
9. The Mayor opened the Public Hearing for Property Tax Rates 2025 at 6:13p.m. There was no public discussion. The Public Hearing closed at 6:16p.m.

Motion was made by ALDERMAN BYERLY with a second by ALDERMAN THERING for the City Clerk to read Resolution 430: A Resolution of the Board of Aldermen Establishing the Annual Rate of Property Tax for the City of Knob Noster for the Next Twelve Months in its entirety. Motion carried 4 ayes to 0 nays. The City Clerk read Resolution 430.

10. MAYOR CARTER read a Proclamation Honoring Tom and Margaret Charrette for their Park donation.
11. Motion to pass Bill No. 081925-A: An Ordinance to Amend Chapter 215.050, Article IV, Certain Debris—Nuisance by Amending Section 215.055 Pertaining to Trees Overhanging Streets and Sidewalks, to its first reading, by title only, was made by ALDERMAN BYERLY, with a second by ALDERMAN SMITH.

Motion carried 4 ayes to 0 nays.

Discussion was held.

MAYOR CARTER had the City Clerk present the Bill by title only.

Motion to pass Bill No. 081925-A: An Ordinance to Amend Chapter 215.050, Article IV, Certain Debris—Nuisance by Amending Section 215.055 Pertaining to Trees Overhanging Streets and Sidewalks to its second reading, by title only, was made by ALDERMAN BYERLY with a second by ALDERMAN SMITH.

Bill No. 081925-A passed 4 ayes to 0 nays. Ordinance number 927 was assigned.

12. Discussion was held regarding Washington Street sidewalks. The City Administrator said that the Public Works Department had isolated a stretch of approximately 210 feet on Washington that they would like to lay sidewalk themselves. Through discussion, it was determined that Public Works will attempt to replace the sidewalks on approximately the first 70 feet.
13. Motion was made by ALDERMAN BYERLY to go into Closed Session Pursuant to Section 610.021 RSMo, Paragraph 3, Personnel with a second by ALDERMAN CHARRETTE. Motion failed 0 nays to 4 nays.
14. Motion was made to adjourn at 6:43 pm by ALDERMAN CHARRETTE and was seconded by ALDERMAN BYERLY. Motion carried 4 ayes to 0 nays.
