ORDINANCE

**AN ORDINANCE SETTING THE REGULAR MONTHLY MEETINGS OF  
THE BOARD OF ALDERMEN AND REPEALING ORDINANCE 439**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF  
KNOB NOSTER, MISSOURI, AS FOLLOWS:**

**Section 1.** The regular monthly meetings of the Board of Aldermen shall be held in City Hall on the first and third Tuesdays of each month at 6:00p.m.

**Section 2.** Special meetings may be called by the Mayor or three or more members of the Board of Aldermen following procedures established in RSMo 610.010-030.

**Section 3.** That Ordinance 439 is in conflict with this ordinance and is hereby repealed.

**Section 4.** This ordinance shall be in full force and effect from and after its passage and approval. Read two times, by title only, passed and approved on this 15th day of June, 2021.
