BILL NO. 071823-A ORDINANCE NO.

AN ORDINANCE OF THE CITY OF KNOB NOSTER, MISSOURI AMENDING ARTICLE IV, SECTION 405.360 "C-4" CENTRAL BUSINESS DISTRICT OF THE KNOB NOSTER CITY CODE.

SECTION 1: The Board of Aldermen of the City of Knob Noster, Missouri hereby amends Title IV, Article IV, Section 405.360 of the Code of Ordinances of the City of Knob Noster, to read, in part, as follows:

Section 405,360, "C-4" Central Business District.

- C. *Permitted Uses*. The retailing of goods and services, public and semi-public uses. Accessory Use Family Dwellings are Permitted.
- D. Intensity of Use Regulations.
 - 1. Accessory Use Family Dwellings are only permitted in combination with an approved primary use within the same structure and must be provided in a separate, designated living area compliant with all other applicable laws and ordinances pertaining to residential use.
 - 2. Accessory Use Family Dwellings may not be on the ground floor unless it is in the rear of the structure.
 - 3. Nine hundred (900) square feet of lot area shall be required for each apartment built above ground floor.

SECTION 2: It is the intention of the Board of Aldermen, and it is hereby ordained, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Knob Noster, Missouri.

SECTION 3: This Ordinance shall be in full force and become effective upon its passage and approval by the Board of Aldermen on this 18th day of July, 2023.
