AN ORDINANCE ADOPTING THE JOHNSON COUNTY LOCAL
EMERGENCY OPERATIONS PLAN 2023

WHEREAS The City of Knob Noster, Missouri is located in Johnson County, Missouri being duly created, organized, and existing under the laws of the State of Missouri; and for the safety of its citizens within Knob Noster city limits; and

WHEREAS, the City of Knob Noster, in conjunction with the Johnson County Emergency Management and the State Emergency Management Agency, have developed an emergency operations plan that will enhance their emergency response capability; and

WHEREAS, this plan is designed to promote the coordination of statewide emergency services and the use of available resources to minimize the effects of a major disaster (natural or otherwise) on life and property of the citizens of Knob Noster; and

WHEREAS, this plan, when used properly and updated, can assist local government officials in responding to and recovering from the effects of natural and man-made disasters,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:

SECTION ONE: The updated Local Emergency Operations Plan incorporated by reference, on file in the office of the Knob Noster Emergency Management Director, is hereby adopted.

SECTION TWO: This Resolution shall take effect this 4th day of April, 2023 and be in full force from and after its passage according to law.

ORDINANCE NO.

An Ordinance Implementing Title III of the Code of Ordinances of the City of Knob Noster, Missouri Regarding Providing False Information to a Police Officer.

WHEREAS The City of Knob Noster is responsible for the safety of its citizens within Knob Noster city limits; and

WHEREAS, it has been deemed by the City of Knob Noster that it is important to be in compliance with this chapter so that law enforcement can effectively complete thorough investigations.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:

SECTION ONE: That Title III, Chapter 200, Section 200.430 is hereby adopted to read as follows:

Section, 200.430. Providing False Information to Police Officer.

1. In accordance with Missouri State Statute, 575.080, it shall be unlawful for any person to willfully or knowingly do any of the following:

(a) Give false statements to a law enforcement officer who is conducting an investigation with the intention of obstructing justice.

(b) Provides false information to a law enforcement officer with the intention of implicating another person in an offense.

(c) Provides false information to a police officer that a crime has been committed or is about to be committed.

(d) Provides false information or causes false information to be made to a police officer or an officer dealing with emergencies that an incident requiring an emergency response has occurred or is about to occur.

SECTION TWO: The provisions of this Ordinance shall be incorporated into the Knob Noster Code of Ordinances.

SECTION THREE: This ordinance shall take effect April 04, 2023, and be in full force from and after its passage according to law.

AN ORDINANCE ESTABLISHING THE SALARIES OF THE ELECTED OFFICIALS FOR THE CITY OF KNOB NOSTER, MISSOURI AND REPEALING ORDINANCE 706

BE IT ORDAINED BY THE BOARD OF ALDERMAN, of the City of Knob Noster, Missouri, that the total compensation for the Aldermen and Mayor will be as follows;

Section I

Regular Monthly Board Meetings - Reference Ordinance 110.170 (A)

Mayor	\$ 100.00 per meeting	Effective Date is May 1, 2023
Alderman	\$ 50.00 per meeting	Effective Date is May 1, 2023

Special Meetings - Reference Ordinance 110.170 (B)

Mayor	\$ 100.00 per meeting	Effective Date is May 1, 2023
Alderman	\$ 50.00 per meeting	Effective Date is May 1, 2023

A meeting is defined as any regular Board of Alderman meeting or special meeting where the Alderman or Mayor attends the meeting in person. Additionally an Alderman or Mayor may attend the meeting via the online platform that the city is using at that time. To be considered attending a meeting via the online platform the clerk and the board must be able to view the Alderman or Mayor who is not attending the meeting in person.

Any Alderman or the Mayor may opt out and not receive compensation by notifying the City Clerk in writing requesting to opt out. If the Alderman or the Mayor that has opted out wants to start receiving the compensation after opting out they may do so by notifying the City Clerk in writing. No back compensation will be given.

Section II Previous Ordinance(s) establishing salaries for the listed elected officials are repealed.

Section III This Ordinance shall be in full force and effect on May 1, 2023 after its passage and approval. Read two times by title only, passed and approved on this 4th day of April, 2023.
