AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF WEST STREET WITHIN THE CORPORATE LIMITS OF CITY OF KNOB NOSTER, MISSOURI.

WHEREAS, the Board of Aldermen of the City of Knob Noster has determined that a portion of a street hereinafter specifically described within the corporate limits has been long abandoned and fallen into general disuse; and

WHEREAS, the City has declined to repair, surface, grade, or, in any manner, maintain said street portion, without any protest or objection from the citizens of the City or from the adjacent property owners of said street; and

WHEREAS, after due consideration, it is deemed that no damages are or will be sustained by the citizens of the City or by the adjacent property owners if said street portion is vacated as contemplated; and

WHEREAS, it is deemed necessary and expedient to the public welfare that said portion of the street is forever vacated, subject to any and all retained easements.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, AS FOLLOWS:

SECTION 1. The Board of Aldermen finds that a portion of West Street, described as follows:

A street thirty feet (30') wide running north and south plotted as West Street (1867) (Known as Reads, Benton & Taylor's Addition) Beginning at McPherson Street and ending at the Union Pacific Railroad Easement.

This was dedicated as a public street but has never been used as such. The Board of Aldermen has determined it would be in the best interest of the City to vacate said street portion as a public street and permit the same to revert to the owners of the adjacent lots in the proportion as it was taken from them.

SECTION 2. The above said portion of West Street is hereby vacated, the same reverting to the owners of the adjacent lots in the proportion it was taken from them. However, the City of Knob Noser, Missouri, hereby retains public utility easement rights for itself and all public utilities for the entire right-of-way. A drawing of said street vacation that identifies the area to be vacated as well as the reservation of public utility easement rights is attached hereto and incorporated herein as **Exhibit A**.

SECTION 3. Nothing contained in this Ordinance or in **Exhibit A** shall prevent the City or any public utility from using said area for public utilities.

SECTION 4. That all Ordinances conflicting in whole or in part with the provisions of this Ordinance are hereby repealed to the extent of the conflict.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.
