**ORDINANCE NUMBER**

**AN ORDINANCE REVISING CHAPTER 715, ARTICLE II, SECTION 715.100 OF THE KNOB NOSTER MUNICIPAL CODE ESTABLISHING ACTUAL USE RATE STRUCTURE WATER RATES FOR THE CITY WATER SYSTEM AND REPEALING ORDINANCE 878**

**NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:**

**CHAPTER 715: WATER**

**ARTICLE II. USER CHARGE SYSTEM FOR WATER SYSTEM**

**SECTION 715.100: ACTUAL RATE STRUCTURE**

A. The minimum charge for:

1. City resident customers per month shall be eleven dollars and seventeen cents (\$11.17) for the first one thousand (1,000) gallons. In addition, each user shall pay a user unit charge of three dollars and sixty-seven cents (\$3.67) per one thousand gallons thereafter.
2. Outside City limits customers per month shall be fourteen dollars and thirty-one cents (\$14.31) for the first one thousand (1,000) gallons. In addition, each user shall pay a user unit charge of seven dollars and six cents (\$7.06) per one thousand gallons thereafter.

**FURTHERMORE**, Ordinance 681, Section IV, Section C is hereby amended to reflect the above.

This Ordinance shall be in full force and effect beginning January 1, 2024, for the February 2024 utility cycle billed on February 1, 2024. Read two times, by title only, passed and approved on this 5<sup>th</sup> day of December 2023.

**NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:**

**CHAPTER 710: SEWER**

**ARTICLE II. SEWER RATES**

**SECTION 710.110: UNIT RATES**

A. Business unit rates are hereby established for usage of the City of Knob Noster sewerage system as follows:

**ORDINANCE**

**AN ORDINANCE ESTABLISHING AN OPERATING BUDGET FOR THE CITY OF KNOB NOSTER, MISSOURI FOR FISCAL YEAR 2024 COMMENCING JANUARY 1, 2024, AND ENDING DECEMBER 31, 2024**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KNOB NOSTER, MISSOURI, AS FOLLOWS:**

**Section 1.** The budget of the City of Knob Noster, as submitted and made apart hereof, aggregating \$2,669,396.30, is hereby adopted as the official budget of the City of Knob Noster.

**Section 2.** The budget aggregating \$2,669,396.30 shall be in full force and effect, unless amended by the Board of Alderman of the City of Knob Noster, Missouri from January 1, 2024, through December 31, 2024.

**Section 3.** This Ordinance shall be in full force and effect from and after the date of its passage.
