## Board of Aldermen Meeting Minutes June 20, 2017

- MAYOR MORTON called the meeting to order at 7:03 pm. All present recited the Pledge of Allegiance. ALDERMAN THERING, BRENT, BABINEAUX, CHARRETTE and ANGELES were present. A quorum was verified.
- 2. The June 6, 2017, meeting minutes were reviewed by the Board of Aldermen.
- 3. The City Council reviewed the bills presented.
- 4. ALDERMAN CHARRETTE gave the City Clerk a listing of potholes that need fixed. She will notify the Street Superintendent for repairs. ALDERMAN ANGELES stated that numerous empty lots around town needed mowed due to tall grass. ALDERMAN THERING stated that the Knob Noster Fair had been a rousing success with numerous patrons attending various events. ALDERMAN BRENT inquired about whether the City picks up stray dogs anymore. CHIEF KNISKERN stated that the Police Department tries to notify owners (if info available) because the only dogs picked up by the PD are classified as dangerous ones. ALDERMAN BRENT also inquired about who is responsible for turning off the Miller Field ball lights when games are over. The City Administrator stated that the last home team playing on Miller field should be responsible for turning off the lights. MAYOR MORTON presented the "Knob Noster Key To The City" to the Knob Noster Fair Board, represented by Jodi Thering, in appreciation of a wonderful 2017 fair. CHIEF BRIAN KNISKERN stated that the Police Department officers did a great job and had no trouble during the fair.

8. Motion was made to approve the Liquor License application submitted by Knob Noster 66 by ALDERMAN ANGELES and was seconded by ALDERMAN BABINEAUX.

Motion carried 5 ayes to 0 nays.

9. Discussion was held regarding the Valley Hill lift station pump failure. Prices include: \$2,400 for a new pump with a 1 year warranty; or \$1,900.00 for a refurbished pump. Motion was made to purchase the new pump with a 1 year warranty by ALDERMAN THERING with a second by ALDERMAN BABINEAUX.
