AFFIDAVIT OF COMPLIANCE/ACKNOWLEDGEMENT

- 1. No more than eight (8) hens per single family detached residence. No roosters, ducks, quail, geese, turkeys, pigeons, guinea fowl, peacocks, or similar fowl shall be allowed in areas not zoned Agriculture.
- 2. Chickens shall not be allowed to roam freely (a fenced run is required).
- 3. Coops and runs may not exceed eight (8) square feet per chicken (four (4) feet for the coop and four (4) feet for the run).
- 4. Coops and runs must be located within the required rear yard setback.
- 5. Coop structures must be located at least ten (10) feet from the property line and at least twenty-five (25) feet from the dwelling or main structure on the applicant's lot.
- 6. Coop structures must be located no closer than one hundred (100) feet from the nearest part of any residence or dwelling upon an adjacent, non-owned lot.
- 7. Coops and runs must be kept in a clean, safe condition.
- 8. Slaughtering of chickens is prohibited.
- 9. Chickens shall be kept for personal use only. Selling chickens, eggs, chicken manure, or the breeding of chickens for commercial purposes is prohibited.
- 10. Complaints of noise, odor, vermin, etc. will be treated as a nuisance violation.
- 11. Violations of this section may result in a daily fine for each day of the violation.
- 12. Nothing in the City Code shall prohibit Homeowners Association from further regulating or prohibiting the keeping of chickens through homeowner.
- 13. Complaints of animal cruelty and neglect shall be investigated.
- 14. \$50.00 fee required once application approved by the Board of Aldermen.
