CITY OF KNOB NOSTER Board of Aldermen Meeting Minutes March 7, 2017

- 1. MAYOR HALL called the meeting to order at 7:00 pm. ALDERMAN CLARENCE CHAFFIN, COHEN, ANGELES, and CHARRETTE were present. A quorum was verified.
- 2. The February 21, 2017, meeting minutes were reviewed by the Board of Aldermen.
- 3. The City Council reviewed the bills presented.
- 4. There was no public participation.
- 5. Doug Kermick presented the City Administrator's report.
- 6. Ms. Savanah McLelland of the Johnson County Board of Services made presentation regarding March being Development Disability Awareness month and all of the services provided by them. Vocation training through the Rise Community Services (Sheltered Workshop) was explained as to what job skills are being taught and performed by the participants of the program, ie manufacturing, recycling, shredding and sales. The City Clerk then read the "Disability Awareness Month" proclamation that was signed by the Mayor.
- 7. Mr. Jerry Akins of the Knob Noster Lion's Club made presentation regarding the programs offered by the Lion's Club to the City of Knob Noster (hearing and vision testing). With the passing of long-standing member and past Mayor, Bob Carr, the Lion's Club wanted to place something at the new City Hall in memorial of his contributions to the City of Knob Noster. Mayor Hall stated that Mr. Akins would need to come to the City Hall with his ideas and the City Administrator will then submit them at a Board meeting for ALDERMAN approval.
- 8. Mr. Benjamin Liechti, 2017 Mayoral candidate, made presentation regarding the need for the City to improve, update and expand the current City website. He handed out a detailed plan to the Alderman for their perusal. Upon finishing his presentation, he inquired if any current Aldermen would be interested in forming a committee to start revising the information presented on the City's website. - Discussion was held regarding the City's 5-Year Street Plan. Streets the ALDERMEN feel need repairing include: Ward I—McKissock, south side of Bagby, Lincoln and Lucas; Ward II—(same list as last year plus) S. Monroe, Madison, Workman and Irish Lane; Ward III—Division Street.
- 10. Discussion was held regarding dates for the 2017 City-Wide Clean Up. Motion was made by ALDERMAN CHARRETTE to hold the Clean-Up May 13-21, 2017, and was seconded by ALDERMAN COHEN.

11. Discussion was held regarding purchasing pews for the new City Hall Courtroom. Motion was made by ALDERMAN COHEN to purchase pews for the Courtroom with a second by ALDERMAN ANGELES.

12. Motion was made to adjourn at 7:53p.m. by ALDERMAN COHEN and was seconded by ALDERMAN CHAFFIN.
