Thomas, Write-In, received 1 vote, Shawn Head, Write-In, received 1 vote, Boden Ronda, Write-In, received 1 vote, with Kevin Goucher receiving 4 Write-In votes to be elected as Ward II Alderman for two years; Wendy Wray received 53 votes and is elected as Ward III Alderman for two years.
